If there is not a tax amount due for a period, enter zero (0.00) on the Total Due line on the return. Your filing frequency is either monthly with prepayment, monthly or quarterly, based on how you completed Form NC-BR, Business Registration Application for income Tax Withholding, Sales and Use Tax, and Other Taxes and Service Charge.
